## III. Course Name and Description

### CMS 750 Leadership and Adminstration in the Church

This is tailored for individuals who are preparing for or are currently in leadership roles within church settings. This course offers a comprehensive look at the principles and practices essential for effective leadership and administration in the church. It delves into biblical leadership models, contemporary management techniques, and practical applications to equip students with the skills necessary for guiding a church in its various facets of operation and ministry.

## **IV.** Course Policies

#### **Class Attendance**

Attendance for an online course is measured by participation in, completion of and submission of online course assignments as assigned/outlined in the course syllabus, schedule and on the course online page. Absence from this online course is determined by the lack of discussion forum post and assignment submissions. Absence from 1 week of an online course is considered excessive, whether excused or unexcused. Part 1: Leadership Portfolio

Total Points: 70

Objective: To synthesize the course's teachings, displaying adeptness in formulating strategies and practices for church leadership and administration.

Components:

- Analytical essays on leadership models and strategies
- Development of church management plans
- Reflections on the role of technology in church administration
- Implementation of conflict resolution mechanisms
- Design of inclusive and engaging community outreach programs
- Format: A collection of written works and strategic plans
- Submission: Via the course portal before the deadline.

Part 2: Comprehensive Final Exam

Total Points: 30

Objective: To assess the student's knowledge grasp and applicative skills of the course content.

Format: Multiple Choice (10 questions, 1 point each), Essay (2 questions, 10 points each)

- Church governance and structure

- Financial management in church settings
- Effective communication and conflict resolution
- Technology's role in church administration

- Insight and Application in Essay Responses (15 points)
