III. Course Name and Description

CMS 752 Preaching in Multiethnic and Multicultural Settings

This course is designed for current and future religious leaders, pastors, and communicators who seek to effectively convey biblical messages in multiethnic and multicultural environments. Recognizing the rich tapestry of cultures and ethnicities in many communities, this course provides students with the tools to navigate and celebrate this diversity in their preaching. It focuses on developing sermons that resonate across cultural boundaries, promote inclusivity, and foster understanding within a varied congregation..

IV. Course Policies

Class Attendance

Attendance for an online course is measured by participation in, completion of and submission of online course assignments as assigned/outlined in the course syllabus, schedule and on the course online page. Absence from this online course is determined by the lack of discussion forum post and assignment submissions. Absence from 1 week of an online course is considered excessive, whether excused or unexcused. Please note that merely logging onto the online learning platform (eLearning) is not synonymous with participation. If you do not participate in discussion forums and submit weekly assignments, you will be counted as absent from the course. Part 1: Multicultural Sermon Portfolio

Total Points: 70

Objective: To apply and integrate course teachings, demonstrating proficiency in creating sermons that effectively engage multiethnic and multicultural audiences.

Your portfolio should reflect your ability to contextualize biblical messages for diverse audiences, incorporating the following:

- Reflection and contemplative consideration on the chosen topic of each sermon.
- Develop a thematic series of sermons addressing key concerns in multiethnic and multicultural congregations.
- Illustrate the application of cultural intelligence in sermon preparation and delivery.
- Incorporate inclusive language and relevant illustrations that resonate across cultural divides.
- Construct sermons that foster community, inclusivity, and understanding.
- Include reflections on feedback received from peer reviews and its incorporation into sermon refinement.
- Explore the use of technology and media in enhancing the accessibility and impact of your sermons.

Format and Guidelines:

Length: Portfolio of 3-4 sermons, each 1500-2000 words

Structure: Introduction, Core Message, Illustrations, Conclusion for each sermon

References: Cite at least three scholarly or theological sources per sermon, in addition to scriptural references.

Submission: Upload to the course portal in a .doc, .docx, or .pdf format before the deadline.

Cultural Relevance and Inclusivity (20 points)
Clarity, Organization, and Creativity (10 points)
Use of Sources and Scriptural References (5 points)
